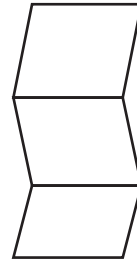

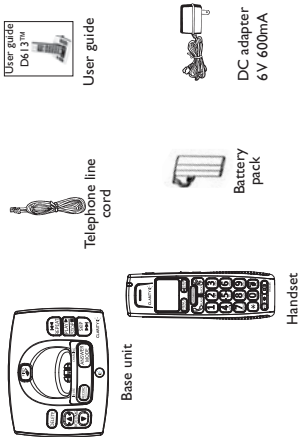

INSTALLING YOUR D613

- Connect one end of the telephone cord into the (square) LINE port on the bottom of the base, connect the other end of the phone cord into our wall telephone outlet. See Figure 1.
- Connect the DC adapter cord into the DC 6V 600mA port on the bottom of the base; plug the adapter into your wall outlet. See Figure 1.
- Slide open the battery compartment door and connect the rechargeable battery into the battery compartment. See Figure 2.
- Put the handset on the base to charge for at least 24 hours before first use. Subsequent charging time should be 6-8 hours a day.

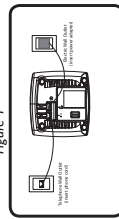
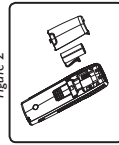

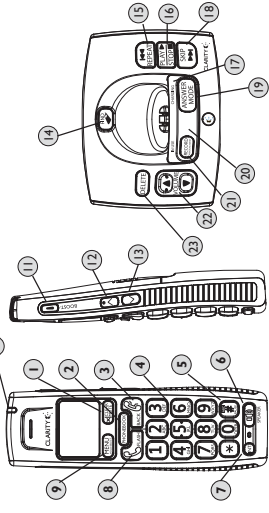
Battery Performance

The battery icon will blink on the menu screen when the battery is low. A fully charged battery will provide an estimated 10 hours of talk time and 100 hours of standby time.

To keep your battery pack in the best condition, leave this handset off the base for a few hours at a time. Removing the battery pack down to the base once with it in its cradle as long as possible. The handset is less alkaline battery. Eventually it will need to be replaced.

Note: Battery pack and handset may become warm during charging. This is normal.

FEATURE LIST AND OVERVIEW



- X/CLEAR/MUTE** button: (Mute/Clear/Delete/Answering Machine main menu); (Idle mode): Press to access the main menu of the answer machine and listen to the voice prompts. (Pre-dial/Editing mode): Press once to delete a character or digit. Press and hold to delete all characters/digits. (During a call): Press this button to mute a call; press again to unmute call. (Calls Telephone mode entry): Press this button to delete the entry. (Answering Machine mode): Press the button or the "0" key to delete the current message playback.
- PHONEBOOK** button: Press this button to access the phonebook. **Note:** The phonebook will hold up to 30 name and numbers.
- (End)/BACK** button: Press to end a call. (Menu Mode): Press to move back a menu level.
- Dial pad/Alphanumeric keypad:** Enter the desired number you wish to call or characters when dialing a name into the phonebook entry. (Tone) During a call, press this button to which you want to tone dialing (temporarily). After the call has ended, the dial mode will return to pause; you can pre-dial (dial before pressing Talk) or press Talk and dial after hearing the dial tone.
- #/PAUSE/ABC/FORMAT** button: (Idle/Pre-dial/During a call mode): Press to insert a # symbol. (In number editing mode): Press once to insert the # symbol and hold # key to insert a pause. (In name editing mode): Toggle between ABC/Alphabetic. (In calls list entry): Press to toggle the Caller ID feature format among 7, 8, 10 and 11 digits.
- SPEAKER** button: Press this button to engage the speakerphone function; press again to turn the feature off.
- INT.** (Intercom): This feature is only available when there are at least 2 registered handsets. It allows you to make internal calls, transfer external calls from one handset to another and use the conference option.
- (Talk)/FLASH** button: Press to make a call, answer an incoming call or to engage the Call Waiting/Caller ID function (feature provided by local telephone company).
- MENU/HOLD/SELECT** button: Press to access the menu list and to confirm/save settings in the menu. (During a call): Press to place the call on hold.
- Top Handset Light:** The light will flash during an incoming call; the light will remain on when you are on a call and the BOOST is on.

FEATURE LIST AND OVERVIEW

BOOST ON/OFF: Press BOOST to engage the extra amplification (screen briefly displays BOOST ON). In BOOST OFF mode, the phone has a volume range of up to 16db of amplification. In BOOST ON mode, the phone has a volume range of up to 30db of amplification.

- UP: Scroll up/Volume up/Call list:** (Idle mode): Press to access call list. (Menu Mode): Press to scroll up. (Editing Mode): Press to move cursor to the left. (During a call/Answer machine mode): Press to increase volume. **During a call/Answering Machine Mode:** Press to decrease volume. (Call Telephone/book/redial list entry): Press to scroll down the list.
- FIND:** Press to find/page all registered handsets.
- REPEAT (Backward):** Press once to replay current message from the beginning. Press twice to playback the previous message.
- PLAY/STOP:** Press to play a message; press again to stop playing message.
- CHARGING light (Red):** Light will turn on red when the handset is in the cradle base charging.
- SKIP (Forward):** Press to skip a message and move forward to the next message.
- ANSWER MODE** button: Press this button to toggle between the following answering machine modes: ANSWER OFF/ANNOUNCE & RECORD/ANNOUNCE ONLY.
- Answering Machine screen:** See section on ICONS for details.
- RECORD ANNOUNCEMENT:** Short press to play current outgoing message. Press and hold to record your own outgoing message and release to stop recording.
- VOLUME UP/DOWN:** Controls the answering machine volume (levels 0 to 8).
- DELETE:** To delete messages, press this button while message is playing; press and hold to delete all reviewed messages. New messages cannot be deleted before being reviewed.

ADDITIONAL HANDSETS

Registering Additional Handsets
The original handset is pre-registered for use. Up to 5 handsets can be registered to one base station. Additional handsets must be registered to the base before you can use them.
1. Place the unregistered handset on the charger.
2. Press and hold the FIND button for 4 seconds on the base.
3. Release the FIND button once the IN USE light starts to flash.
4. A confirmation tone will sound when registration is successful. Handset X is displayed where X denotes the number of handsets. The phone will then go back to idle.

De-register All Handsets

- Unplug the power from the base.
- Press and hold the FIND button on the base for 10 seconds.
- Plug back in the power of the base.
- Release once the IN USE light starts to flash rapidly.
- Within 2 seconds, press and release the FIND button on the base again. This will de-register all handsets. The IN USE light on the base will be OFF and NOT REGISTERED will display on each handset's menu screen.

RESET SETTINGS

Reset All Settings

This will reset all the personalized settings to the default settings.
Note: All entries in the Phonebook, Redial List and Call List will be cleared.
1. Press the MENU button and use the UP/DOWN buttons to select Reset All Settings.
2. Next, press the MENU button and use the UP/DOWN buttons to select All Settings.
3. Press the MENU button to select Yes.

MENU OPTIONS

There are six main menu options on the D613: Date & Time, Phonebook, Setup HS, Setup BS, Answer Machine and Reset Settings.

- To navigate through the menu:
- Press the MENU button;
 - Press the UP/DOWN arrow buttons to scroll through the menu;
 - Press the MENU button to open a sub menu or to select an option. Press the (Talk/Off)/BACK button to go back to the previous menu level or to cancel an action.
- Note:** If you do not press any button on the handset for 30 seconds the display will automatically return to standby.

CALL LIST (CID)

This is a service provided through your local telephone company. The D613 will automatically record up to 30 calls. The time and date will automatically register after receiving your first call.

Call List (CID)

The call list contains the missed and received calls. Entries are displayed in chronological order with the most recent call at the top of the list. When there is a missed call that has not been answered, NEW will be displayed on the menu screen.
Notes: When the call list is full, a new call replaces the oldest in the list. If you receive more than one call from the same number, only the most recent call is kept in the call list.

View Call List

To View the Call List information press the UP button while your phone is in idle mode, the most recent number will be displayed. Press the UP/DOWN buttons to scroll through the call list.

Formatting Call List Information

When reviewing an entry from the call list, press the # button repeatedly to display the number in different formats. For example, if the call number is displayed as 800-426-3738, the various formats will be: 426-3738, 1-426-3738, 800-426-3738 and 1-800-426-3738.

Save Number from Call List to Phonebook

- Use the UP/DOWN buttons to scroll to the CID entry you would like to save.
- Press the MENU button and enter the name, using your dial pad.
- Press the MENU button once again to edit the number.
- Press the MENU button and use the UP/DOWN buttons to select your desired melody.
- Press the MENU button to save to the Phonebook.

Note: Up to 20 names and number can be stored into the phonebook. Numbers can be stored up to 24 digits long and names can be up to 16 characters long. Entries will be stored in alphabetical order.

Delete a Call List Entry

- Press the UP button to enter the call list.
- Press the UP/DOWN buttons to your desired entry.
- Press the CLEAR/DELETE button to delete the entry.

Delete Entire Call List

- Press the UP button to enter the call list.
- Press and hold the CLEAR/DELETE button until "DELETE ALL CALL LOG ENTRIES" is displayed.
- Press the MENU to confirm and delete all entries.

BOOST FUNCTION AND VOLUME CONTROL

Boost Function - Amplify Incoming Sounds

1. While on a call, press the BOOST button. The D613 has a BOOST button that controls the loudness of the receiver. Once the BOOST button is pressed, an extra level of amplification is added over the entire range of the Volume Control. During a call, the BOOST button can toggle the Clarity Power function On or Off according to the user's needs. The BOOST button will illuminate automatically every time the phone is hung up for at least 5 seconds. The top light will illuminate (Red) while the phone function is activated.

2. During a call, press UP/DOWN buttons to adjust the volume to the desired sound level (up to 30 db of amplification) on the speaker or loudspeaker. The Volume Control adjusts the level of volume in the handset and both BOOST or non-BOOST modes. The Volume Control provides up to 16 db of volume before the BOOST button is activated.

CAUTION: VOLUME MAY BE LOUD. PROCEED WITH CARE.

MENU OPTIONS

Setup BS (Base) (Main Menu)

Submenu settings allows you to select your personalized settings for the base: Ringer Tone (Melody settings 1-3), Ringer Volume (1-5), Dial Mode and Area code.

Answer Machine (Main Menu)

Submenu settings allows you to set the following: Answer Machine (Answer, Off/Announce & Record/Announce Only), Message Alert (On/Off), Set Number of Rings before the Answer Machine picks up, Announcement (Announce & Record/Announce Only), Record Memo, Call Screening, Remote Access (On/Off) and set your own security code for remote access (default security code is 123).

Reset Setting (Main Menu)

Submenu settings allows you to select your Voice Mail (services provided by your local telephone company) or to reset All Settings to the default setting.

Date and Time (Main Menu)

The submenu will allow you to manually input the Year, Date and Time. If you have CID service (service provided by your local telephone company), this information will automatically register during your first call.

Phonebook (Main Menu)

Submenu settings allows the following options: View, Add, Edit, Delete, All, Check your Phonebook Capacity and Set your Speed Dial for keys 1-9.

Setup HS (Handset) (Main Menu)

Submenu settings allows you to select your own personalized settings for the handset: Ringer Tone (Melody settings 1-3), Ringer Volume (Off, Vol. 1-5), Key Tone (On/Off), Low Bat Tone (On/Off), Out of Range (On/Off), Tone, Handset Name and Language (English/FRENCH/SPANISH).

TROUBLESHOOTING

Charging

- The Battery icon is not showing that it is charging when the handset is placed on the base.
1. Bad battery contact - move the handset slightly.
 2. Dirty contact. Clean the battery contact with a cloth moistened with alcohol.
 3. Battery is full, no need to charge.

No dial tone

- If no power, check the connections. Reset the phone; unplug and plug back in the electrical outlet.
1. The Battery has lost its charge. Charge the battery pack for at least 24 hours.
 2. You are too far from the base, move closer to the base.
 3. Make sure that you have used the telephone line cord and DC power adapter provided.

5. Make sure that the DC power adapter is connected correctly.

Poor audio quality

1. The base may be too close to electrical appliances, reinforced concrete walls or metal door frames. Place the base away from any electrical appliances.

Caller ID service does not work

Check your subscription with your network provider.

A phonebook entry cannot be stored

The phonebook may be full. Delete an entry to free memory.

No display

1. Try recharging or replacing the battery pack.
2. Reset the telephone base. Unplug the unit's electrical power, then plug it back in.

Registration

Unable to register another handset

1. Be sure that it is a Clarity expandable handset that is compatible to the D613.
2. If there is a total of 5 handsets registered, the maximum has been reached.
3. The display shows NOT REGISTERED. You must de-register a handset in order to register a new one.

TROUBLESHOOTING

Handset loses the link to base during use

1. Check the power cord is connected properly into the telephone base.
2. Make sure the DC power adapter is connected properly into an electrical outlet.
3. Move the cordless handset closer to the telephone base. It may be out of range.
4. Reset the telephone base by unplugging the unit's electrical power. Wait for around 15 seconds and plug it back in again. Allow up to one minute for the cordless handset and the telephone base to synchronize.

Static On The Line

1. Your phone may be located near a touch lamp, microwave, refrigerator or other household appliances. Try relocating your phone to another area.
2. A cordless phone on your line may cause static. Try disconnecting the cordless phone. This may eliminate the problem.
3. Extra devices attached to the telephone, such as CID units and answering machines may cause static. Disconnecting the devices may eliminate the problem.
4. If there is also a DSL service in the home, this will cause interference on the line. That interference is then amplified by the phone, causing a less than optimal quality of conversation. Install the phone line filter provided by the DSL service provider to reduce the amount of interference on the line.

Interference

1. Check cords and connections. Frayed or poorly connected cords can cause interference. Swap cords if necessary.

Noise interference on your radio or television

Your base or charger may be too close. Move it as far away as possible.

Answer Machine

1. Make sure the answering machine is on.
2. The memory may be full. If so, you will need to delete some messages.

Still Not Working?

If after going through this checklist, the D613 is still not functioning properly, call Clarity at 1.800.426.3738.

The customer should be aware that compliance with the above conditions may not prevent degradation of service in some situations. Repairs to certified equipment should be made by an authorized Canadian maintenance facility designated by the supplier.

Any repairs or alterations made by the user to this equipment, or equipment malfunctions, may give the telecommunications company cause to request the user to disconnect the equipment.

Users should ensure for their own protection that the electrical ground connections of the power utility, telephone lines and internal metallic water pipe system, if present, are connected together. This precaution may be particularly important in rural areas.

CAUTION: Users should not attempt to make such connections themselves, but should contact the appropriate electrical inspection authority or electrician, as appropriate.

The Ringer Equivalence Number is an indication of the maximum number of terminals allowed to be connected to a telephone interface. The termination on an interface may consist of any combination of devices, subject only to the requirement that the sum of the Ringer Equivalence Numbers of all the devices does not exceed that value.

This Class B digital apparatus complies with Canadian ICES-003.

(The term "IC:" before the certification/registration number only signifies that the Industry Canada technical specifications were met.)

1. Where it can be done safely, reorient the receiving television or radio antenna.

2. To the extent possible, relocate the television, radio or other receiver with respect to the telephone equipment. (This increases the separation between the telephone equipment and the receiver)

3. Connect the telephone equipment into an outlet on a circuit different from that to which the television, radio, or other receiver is connected.

4. Consult the dealer or an experienced Radio/TV technician for help.
